Message from the Board Chair and Chief Executive Officer

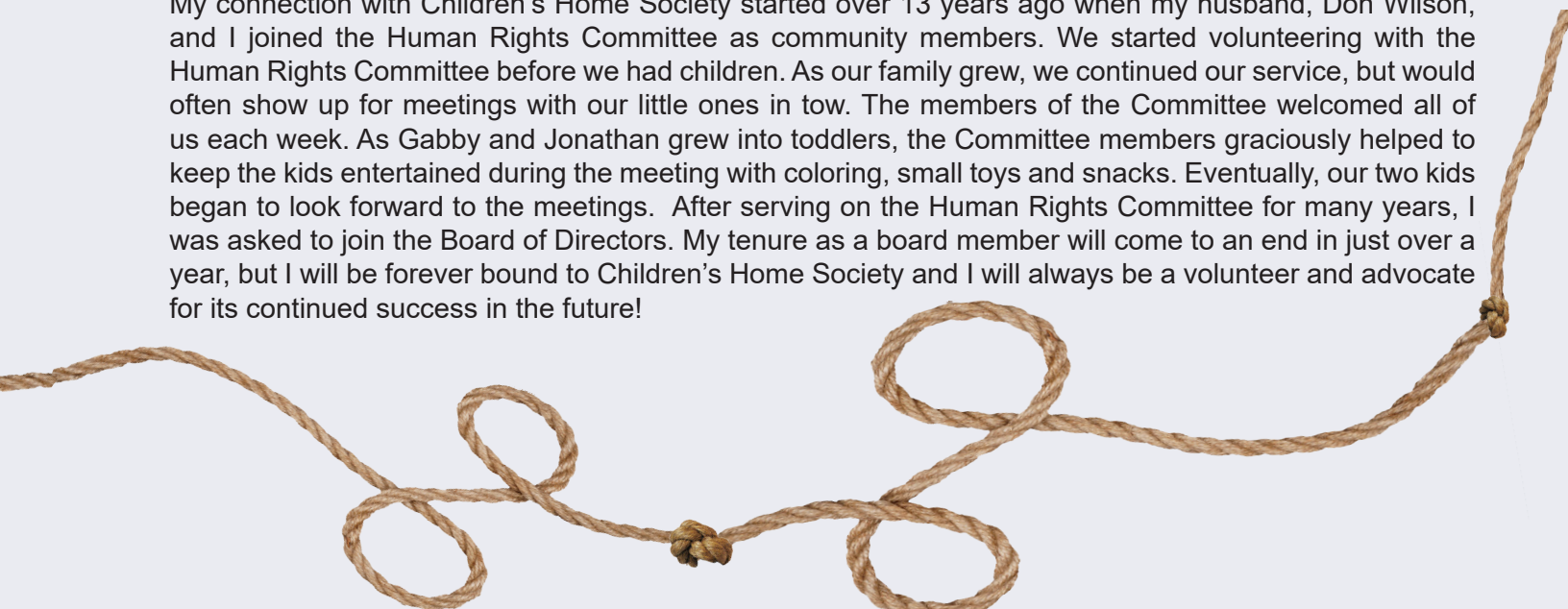

The Children's Home Society is committed to the children and families of West Virginia with an unbreakable connection and shared belief that together we have it all. Our ties to our communities have been strong and lasting. Our ties to our mission and vision is evidenced in our 128 years of service to West Virginia's most vulnerable children, youth and families. It is heart of each committed individual that binds us all together as one.

The Mission & Vision Ties It All Together

The Children's Home Society of West Virginia is a private, non-profit child welfare organization founded in 1896. The Society is a participatory organization consisting of employees, foster families, adoptive families, volunteers, Board members, Directors Emeriti, advisory council members, donors, benefactors, supporters, and friends. We are governed by a volunteer Board of Directors that is representative of the communities we serve from around the state. We are licensed to provide child welfare and behavioral health services in West Virginia. We are a member agency of the Emergency Shelter Providers Network, the National Council For Adoption, the Foster Family Treatment Association, the Youth Collaboratory and the Children's Home Society of America. We are fully accredited by the Council on Accreditation of Services for Families and Children.

Comprehensive child welfare, behavioral health, social casework and advocacy services were provided to **18,661** children and families during the 2023/2024 fiscal year from 13 primary locations throughout the state. Some of our current programs are adoption, foster care, in-home and in-community services for children and families, emergency shelter care, parent education training, prenatal and early childhood services, volunteer and mentoring, visitation and reunification, school based social work, and comprehensive assessment services.

The Mission of the Children's Home Society is to promote the well-being of children. Our current efforts are directed at helping children find lifetime families, protecting and nurturing children, and helping preserve and strengthen their families.

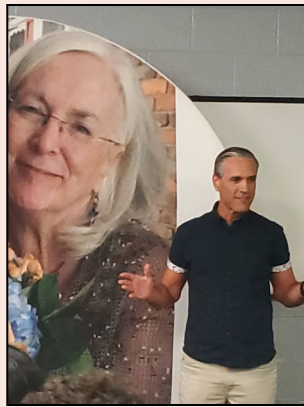
Our Vision

Ties that Pulled Ava Out of a Dark Place

The Children's Home Society's Independent Living Program provides services to young adults moving to independent living who have previously been in the foster care system. The goal is to prepare them for independence and self sufficiency. We accomplish this by assisting with individual education, housing, and employment needs. The approach is holistic, and includes well being, developing permanent connections, and physical and mental health needs.

Children's Home Society believes all youth deserve opportunities to succeed and reach their full potential. The Society pledges to help youth and young adults be safe, supported and successful by providing services that foster independence, resourcefulness, and lasting connections with a caring adult.

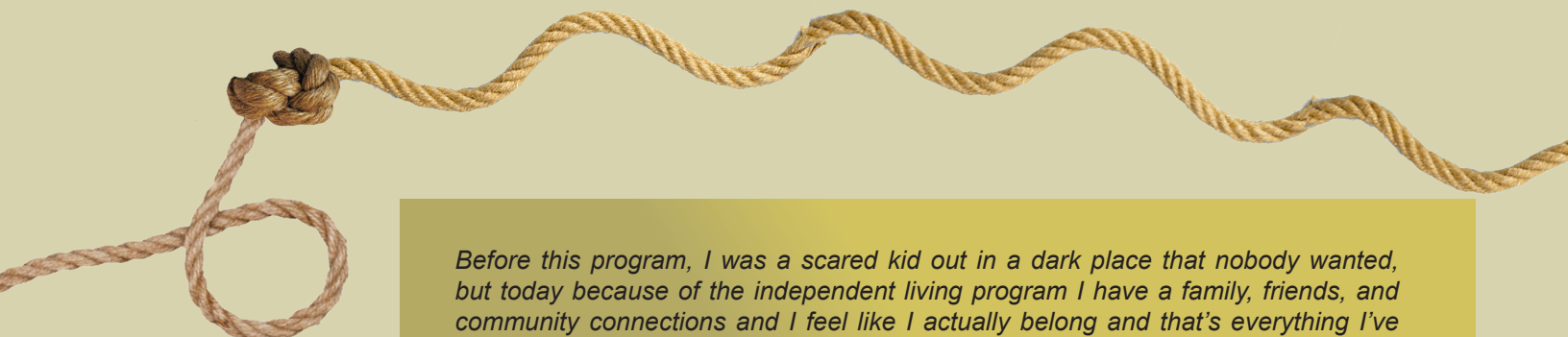
Below is Ava's story...

Ava was referred to the Independent Living Program (ILP) by her guardian ad litem following her court proceedings. At six months old, Ava was adopted by her abusive grandfather, which preceded a series of unstable and abusive caregivers, juvenile detention, and residential placements. Ava faced becoming homeless at the age of 18, as her kinship placement was no longer an option as a place for her to live. Initially, she was reserved and guarded during her intake into the program, fearing others having further control over her life. ILP social worker reassured her that the ILP was designed to provide support and assistance and explaining it is a voluntary program.

As Ava had to leave her living situation immediately, she initially planned to stay with a friend. Unfortunately, this arrangement fell through. The Department of Human Services (DoHS) was able to support CHS with a hotel stay for Ava while she worked with the ILP social worker to secure stable living. Ava and ILP social worker successfully found an affordable apartment and a landlord willing to give Ava an opportunity. Ava also learned the ropes of setting up utilities and internet services. She received generous support from her Guardian ad Litem (GAL) and her network, who helped furnish her new home with essential items.

With guidance from ILP social worker, Ava secured Medicaid and SNAP benefits, enhancing her nutritional security. Ava recently began therapy to address her mental health needs with professional support. She has also become open to regular health check-ups and began attending doctor's appointments.

Ava most recently secured employment after being in ILP for a little over a month. Her job is conveniently located within walking distance from her apartment. Ava is interested in finding a career in the future and is excited to explore more of her interests. Ava continues to seek support from her ILP social worker and GAL.



Before this program, I was a scared kid out in a dark place that nobody wanted, but today because of the independent living program I have a family, friends, and community connections and I feel like I actually belong and that's everything I've ever wanted.

Fostering Ties, That Last A Lifetime

The Children's Home Society wishes to thank our dedicated foster care staff, foster parents, and adoptive parents for assisting and creating homes for hundreds of children statewide. Last year, our foster parents providing a loving home to **524** children. The Society's foster families are not only providing a safe and loving home environment, but they also help bring permanency to the lives of West Virginia's children.

The mission of the Children's Home Society is to promote the well being of children with current efforts to help find lifetime families. Last year, **102** children found a lifetime family through adoption program.



Unbreakable, Life Changing, Connections

The Society's Emergency Child Shelter Program provides statewide care to children in crisis. Our 8 Emergency Child Shelters cared for **451** children last year. Although our emergency child shelters provide a safe environment in a home like setting where the basic needs of children can be met, these homes are a place children can come to be inspired, to learn, to believe in what they can accomplish. They over-come past adversities and find hope for their future.

Weaving Resources Together Impacting Thousands

Our Resource Centers play an important role in our efforts to help families in their own communities across the state. They provide a variety of items to help meet emergent needs and assist families during times of financial hardships.

During the 2023-2024 fiscal year, our Resource Centers assisted **1,856** individuals statewide. These children and their families were able to benefit from the in-kind support given to CHSWV by numerous businesses, individuals, churches, and civic groups throughout West Virginia.

Family Support Centers (FSC) are community-based programs designed to support families by strengthening parent/child relationships, provide supports parents need to be good nurturers and providers, and to gain or maintain self-sufficiency. These programs serve as welcoming hubs of community services and opportunities. They are designed to strengthen families, reflect and be responsive to the specific needs, cultures, and interests of the communities and populations served.

During the 2023-2024 fiscal year, our Family Support Centers assisted **5,279** children and families. The centers are unique in their approach to working with families. They build families' strengths and capacities, work for positive social change, and offer help without stigma. Parents may act in many capacities, such as serving on a decision-making board, participating in programs, or planning and participating in community events.
