# **Children's Home Society Announces Al Wade Storytelling Award Winners**



#### **About our Honoree**

Al Wade has given 31 years to serving children and families. Al came to the Society in September 1989. In his early days as a social worker, Al was known for being one of few that always saw his children and youth in placement and always put them and their needs first. Al supervised a variety of programs, some of which included: Paul Miller Home, Southern West Virginia Exceptional Youth Emergency Shelter and is credited for opening the Forever Families Center in Northfork. There is no way to capture the children and families that Al had the opportunity to impact over his many years of service to Children's

Home Society of WV, but Al had a way of sharing stories of his experiences and the youth he served. Al has a flare for telling a story with love, passion and an infectious laugh. His stories would evoke strong emotions from within as they focused on our children and their lives - their wins, challenges, you can't make this up stories, and most importantly how someone helped change the trajectory of a child's life. His stories fueled our inner fire with an even greater desire to help children and families.

# Children's Home Society Announces Nancy Stuart-Tonkin Advocacy Award Winner

The Children's Home Society of West Virginia hosted its Annual Board Meeting/Dinner on November 14, 2024 at the Holiday Inn & Suites in Charleston, WV. During the meeting, Sarah M. Whittaker was named the winner of the 7th Annual Nancy Stuart-Tonkin Advocacy Award.

Sarah began her career at our Princeton location in 1989 as an adoption worker. As she continued to grow the Princeton location, she became site manager. Sarah was a tireless advocate and believed in the importance of developing strong relationships with the West Virginia Department of Health and Human Services and other social services agencies. Besides building a reputation for adoption services and support, Sarah led the way for more comprehensive preventive support for families. She established a Right From the Start program for several under served counties, bringing early intervention services to the doorstep of rural WV homes. Soon to follow was an inhome service initiative to prevent at risk families from becoming open Child Protective Services cases, and the removal of children.

Sarah was on the front-lines in influencing policy and practice for these early in-home prevention services. She was involved in the up-grading and universal PRIDE training for all foster parents as she was an integral part of a panel of other foster care providers, state officials, and educators to churn out and oversee this critical pilot project to improve the quality of WV foster care. She helped CHSWV find its way as a private foster care agency, building on her knowledge and experience in adoption work, and promoting the best interest of the child above all else. This was a time of tremendous growth and program expansion for CHSWV and because Sarah was a strong multi-dimensional advocate, Children's Home Society became a leader in child welfare for Southern WV.

Sarah left CHSWV in 1999 to accept a full-time teaching position in the Social Work Department at Concord College. While her job changed, her zeal for advocacy continued and shifted to her students and the community at large. She also became the number one WECAN Mentoring recruiter, as she encouraged her students in the Intro to Social Work class to become volunteer mentors, invited the WECAN staff to speak in her classes about the program, and urged her fellow professors to do the same. Sarah's legacy for advocacy followed her through her career at Concord, which elevated to University status (2004) during her tenure and added the most successful and innovative on-line MSW program (2015) to their already well-respected and growing Social Work Department. Sarah retired from Concord University this summer (2024) but her influence will be felt for many years and generations in so many ways through the students that she nurtured through policy, practice, theory, statistics, and untold classes as well as social work placements.

During Sarah's tenure on the CHSWV Board of Directors, there were ample opportunities for her to tap into her wealth of child welfare knowledge along with her lengthy list of service providers, contacts, agencies and associations to further a variety of CHSWV ventures and initiatives. One example is the opening of Jan's House in Huntington which houses the Nancy Stuart-Tonkin Resource Center. Turns out that one of Sarah's childhood friends was the Mayor of Huntington and she did not miss a beat in getting him and the city on board with the expansion project for CHSWV and the children and families in his city.

Sarah is steady, reasonable, practical, along with persistent, visionary and positive in her advocacy for herself, her family, her staff and colleagues, her students, her clients, and her community. Sarah has consistently supported high standards, training and support for foster parents both at CHSWV and CU. She shared her insights with the PRIDE Training Team to improve how foster parents and kinship parents are prepared for their roles in caring for traumatized children. She has witnessed many ups and downs as the foster care program slowly emerged from very few standards toward federal and best practice standards. She has impacted this program through her preparation of social workers, through her participation on boards and committees, and oversight panels and always with advocacy in the forefront.

Her lifetime of social work advocacy as evidence by her nearly 50-year career with DHHR, Children's Home Society and Concord University is more than proof of her extra-ordinary commitment to children, families and communities. (Joanne Boileau - September 2024)

#### **About our Honoree**

The Children's Home Society of West Virginia Board of Directors established the Nancy Stuart-Tonkin Advocacy Award beginning in 2018 to annually honor an outstanding advocate who has successfully promoted the well-being of children and families in West Virginia.

In the 1970's Nancy Tonkin helped organize the first Multidisciplinary Team (MDT) effort in West Virginia and after that successfully worked to make the MDT's part of the child welfare law. She also helped make the role of guardian ad litem part of public policy. Later she was a leader in getting per diem rates for private agency foster care increased from \$35 to \$55.

Other child welfare initiatives that Nancy championed included; family resource networks, infant screenings, home visitation and efforts around child abuse prevention. For 40 years Nancy worked to ensure that child welfare laws were designed to protect children and preserve families.

Nancy was a trusted advisor to the Children's Home Society in all public policy matters. She was one of our strongest advocates for our permanency and child well-being efforts.


#### **About the Honoree:**

Ruth Eden Bailey dedicated her life to helping children find lifetime families. She was a determined advocate and worked tirelessly to find foster and adoptive homes. Ruth loved working with her families and the children that came into care, she was mission driven and her passion inspired many. Bob Noone said it best, "Ruth was the standard by which we measured all other adoption specialists in WV. Ruth began her journey with Children's Home Society in 1993 and spent the following three decades changing the lives of hundreds of West Virginia's children. Ruth was always looking for ways to help support foster and adoptive families and thus she initiated the first CHSWV Foster Family Support Group. The Foster Family Support Group became significant in that it brought families together to share experiences, to be supportive during struggles and are organized and most importantly to celebrate each other. Today CHSWV foster family support groups are organized across



the state thanks to a special woman that was creative, passionate and enthusiastic. Ruth left a legacy of encouragement, love and kindness.


